

Wayfarers Chapel Instagram Photo Contest
Official Contest Rules and Regulations
February 1 through February 28 2018

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Campaign is open only to those who submit/post a photo on Instagram with the hash tag Wayfares Chapel Photo Contest (#wayfarerschapelphotocontest). Participants must also tag Wayfarers Chapel (@wayfarerschapel1), and tag one(1) friend. There is no age limit to enter. The campaign is open to anybody who comes to visit Wayfarers Chapel and who signs this Official Contest Rules and Regulations form. Void where prohibited by law. Employees of Wayfarers Chapel, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. 3. **Campaign Period:** Entries will be accepted online starting February 1, 2018 at 12:00am Pacific Time and ending March 1, 2018 at 12:00am Pacific Time. All entries must be received by March 1, 2018 at 12:00am Pacific Time.
4. **How to Enter:** The Campaign must be entered by:
 1. Visit the Wayfarers Chapel and sign the Rules and Regulations Form
 2. Take a picture **of the ocean** from anywhere on the grounds of Wayfarers Chapel
 3. Post said picture on your Instagram account along with the hash tag #wayfarerschapelphotocontest, tag @wayfarerschapel1, and tag one(1) friend of your choice.(Description can be anything you wish) The entry must fulfill all campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Wayfarers Chapel. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple Instagram accounts, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Wayfarers Chapel.

The Winners photo will be used as the artwork for our fliers, posters and other advertising for the Wayfarers Chapel 2nd Annual "Art By the Sea Art Show with Poetic Expression 2018". The specifics of the prize shall be solely determined by Wayfarers Chapel. No cash or

other prize substitution shall be permitted except at Wayfarers Chapel's discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or requests for the cash equivalent by Winner(s) is permitted. Wayfarers Chapel shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner(s) cannot be contacted, is/are ineligible, fails to claim prize within 60 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and alternate Winner(s) selected. By entering this Content, you represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary rights of any third party, You shall, at your sole expense, defend or settle against such claims. You shall indemnify, defend and hold harmless Wayfarers Chapel from and against any suit, proceeding, claims, liability, loss, damage, costs or expense, which Wayfarers Chapel may incur, suffer, or be required to pay arising out of such infringement or suspected infringement of any third party's right.
9. Terms & Conditions: Wayfarers Chapel reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud or other cause beyond Wayfarers Chapel's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Wayfarers Chapel may select Winner(s) from all eligible entries received prior to and/or after (if appropriate) the action taken by Wayfarers Chapel. Wayfarers Chapel reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry

process or the operation of the Campaign or Website or violates these Terms & Conditions. Wayfarers Chapel has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including but not limited to: multiple entries from the same user from different IP address; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots macros, scripts or other technical means for entering.
